NEW THIS YEAR – RECORD SAVER ENVELOPES

To help you prepare for the upcoming tax season, we have enclosed a Record Saver Envelope. This envelope is designed to help you by having one place to put all your documents and give you reminders of possible documents you should bring us.

WATCH FOR THIS IN JANUARY – You will receive notices from IRS stating the amount of Stimulus Dollars and/or Advance Child Tax Credit in 2021 (if you qualified). Accurate tax returns cannot be prepared without this information.

The past two tax seasons have been extended by 30 and 90 days. This resulted in our office serving more clients in a longer time frame. That time frame has now been reduced to the original due date of April 15th.
Resulting in 4 or 6 months of work now due in 3 ½ months.

Due to this, if your information is not in our office by March 10th, please be advised that an extension may be necessary. This is not an ABSOLUTE, but it is a possibility.
